Supervisory Report

As your Supervisory Committee, we are responsible for monitoring the credit union's operations and procedures on behalf of the membership. Some of our responsibilities include: reviewing closed accounts, new loan reports, bank reconciliations, cash over/short reports, corporate Visa statements, Board and Management's accounts and member account verifications.

In addition to the items reviewed, we also periodically conduct surprise cash drawer audits on our front line staff. Each year we commission an annual audit performed by an independent CPA firm to verify the credit union is following the policies set by the Board of Directors and to ensure that the credit union is operating in a safe and sound manner. This past year, 2019, we contracted Moss Adams LLP to conduct the annual audit. Moss Adams is one of the 15th largest accounting and consulting firms in the United States and provides service to more than 300 financial institutions, including approximately 100 credit unions. I am happy to announce the credit union had a very clean audit again in 2019.

Our current Supervisory Committee members are Judy Jones, Jason McVey, Penny Sudderth and myself, Denny Evans, as your Chairperson. We would like to thank Stacie Barnum and Farol Olsen for their service.

I'm happy to report, your credit union is performing exceptionally well. We had another very strong year of growth. Below is a recap of our 2019 financial results.


The assets of the credit union increased 11.31% to end the year at \$164,753,465. There was significant growth in regular shares at \$12,272,865 and share draft accounts show an increase of \$1,864,249.

Membership continues to grow with 2019 adding 830 members and total reserves of \$23,185,643, which gives us a very healthy net worth of 14.07%. For Envision: 2020, our focus will remain on increasing loans and membership and strengthening our position in our newest branch area - Chehalis.

I am hopeful that 2020 will be a year of prosperous growth for your credit union.
